I refer to the application for a waste management licence in respect of the above facility.

The draft licence conditions (including location plan) has now been prepared and a copy is enclosed, which you may comment upon if you wish.

This draft licence together with the other relevant details supporting your application have been sent to the The City of Stoke-on-Trent Planning Department and the Health & Safety Executive in their capacity as bodies whom the Agency is required to consult by statute for their comment before further consideration can be given to your application.

I would advise you that –

- (i) this application and associated documents will be put on the Environment Agency's public register, unless you have previously indicated by letter that you wish certain details of the application to remain confidential and that this request has been agreed by the Environment Agency.
- (ii) the period laid down for consultation is 28 days but this may be extended if necessary and the draft licence may be subject to alteration depending on the results of the consultation described in paragraph 3 above or seen to be appropriate by the Agency.

Finally, I would stress that the draft licence attached herewith has been prepared solely for consultation purposes. It does not imply that a waste management licence will be issued, nor that it will be issued in the terms therein and it does not authorise the carrying out of any waste disposal activity at the above site.
